construction of the Fitch Street Substation/Cervalis projects.

Smith also covered major projects on the horizon for TTD, including the installation of a T1 transformer on East Avenue, which will be completed within the next 4-6 weeks. This installation will help to increase reliability by evenly distributing loads across the district.

Commissioner David Brown presented the district budget for review and approval by the electors. The group discussed plans for the East Norwalk Association Library, based on the earmarked funds for a third-party master plan. Commissioner Charlie Yost stressed the importance of having a committee of stakeholders involved in any discussion and decision-making regarding the East Norwalk Association Library.

After a spirited discussion between the Commissioners and ratepayers, the district budget was approved with minor changes.


Survey Results (Continued)

TTD Compares Rates to CL&P

During the TTD Annual Meeting, General Manager Jim Smith presented an “apples-to-apples” rate snapshot comparing TTD rates to CL&P rates. The snapshot revealed that TTD’s rates are significantly lower than standard CL&P rates for the same level of service, and even with options available in Generation Suppliers for CL&P customers, TTD rates are still lower, by approximately 15%.
