

TTD Update on Library Master Plan

The Commission of the Third Taxing District (TTD) is pleased to inform the residents of the positive progress made with regards to the implementation of the East Norwalk Improvement Association's (ENIA) Master Plan for the East Norwalk Library.

Together, TTD and the ENIA fully support the goals in the Master Plan, which is to collaborate in defining the direction of the library with an emphasis on identifying high priority initiatives including costs, timing, funding sources, and staffing/resourcing.

The implementation strategy will guide the actions, responsibilities and budget decisions of the ENIA Board of Directors overseeing library services, programs and facilities. Specifically, the priority and optimal timing for carrying each action plan forward, as well as financial impact. To date, the ENIA is poised to hire a full-time executive director with a Master's Degree in Library Science. This is a major step in the future of the library that will serve the community in alignment with the Board of Directors.

TTD is continuing to light the tree in Ludlow Park each month in support of a different cause.


We kicked off 2017 with blazing red lights in February to bring awareness and show our support during American Heart Month.

We encourage the residents of East Norwalk to spread the word about the worthwhile efforts of these organizations and their causes.


The More you Read
