Mr. Plunkett called the meeting to order at 7:00 p.m.

PUBLIC COMMENT

Mr. Nelson and Mr. Tracy thanked the Commission for the use of 215 East Avenue. They submitted a rent check for \$3.00.

GENERAL MANAGER'S REPORT

Mr. Leary reviewed his written report. He said that CMEEC met with CL&P and it is not encouraging

Mr. Leary reported that they have not yet heard anything from Mr. Lyons' arbitration. A part time meter reader gave their notice. He recommended hiring a replacement. Mr.

Third Taxing District Special Meeting July 13, 2009 Page 1 Leary read the notice that Mr. Lyons asked to have his case moved from the CHRO to court; they have agreed to allow him to do that.

Mr. Leary said that he talked with Wachovia Bank and said that they have a number of fees. Fairfield County Bank and Patriot Bank will both give the District a good deal; the difference is that there is a \$2 million collateral agreement with Patriot Bank.

Mr. Leary talked about the "smart grid" and said that they have to make a decision quickly. He said that he is not in favor of doing this, because there are no standards and he does not believe it will save the District any money. There is a rush, because this is using stimulus funds.

The Commissioners discussed the pros and cons of participating in the Smart Grid initiative. There was no action taken.

TRANSFORMER UPDATE

Mr. Cristino updated the Commission on the transformer project. He said that it was delivered last Wednesday. Overall the project is on schedule and on budget.

GENERAL MANAGER'S REPORT (continued)

Mr. Leary reviewed the financials. He said that residents are using less electricity and conservation is eating away at the profits. Mr. Leary said that he projected a profit of approximately \$400,000. Mr. Leary reviewed the power supply report dated April 2009 and the TTD Electric Department Sales report dated April 2009.

Mr. Leary reviewed the Regional Greenhouse Gas Initiative fund activity dated April 30, 2009. He explained that the funds can only be used for energy conservation.

Mr. Leary reported that a customer located at 66 Van Zant Street is requesting a \$27,000 solar PV rebate. For full disclosure, Mr. Plunkett stated that he knows the owners of 66 Van Zant Street since high school and would be willing to excuse himself from this discussion.

Mr. Leary distributed copies of bids from actuarial services.

WHEREAS, THE BYLAWS OF TRANSSCO SET FORTH THAT EACH OF THE MEMBERS SHALL APPOINT TWO (2) REPRESENTATIVES TO THE TRANSCO BOARD OF DIRECTORS; AND THAT REPRESENTATIVES AND ALTERNATE REPRESENTATIVE SHALL BE APPOINTED FOR A TERM OF THREE (3) YEARS.

NOW BE IT RESOLVED, THAT THE THIRD TAXING DISTRICT HERBY APPOINTS DAVID BROWN AND GEORGE LEARY AS REPRESENTATIVES ON THE BOARD FOR TRANSCO FOR A TERM OF THREE (3) YEARS AND PAUL KOKIAS AND TIMOTHY PLUNKETT AS ALTERNATE REPRESENTATIVES ON THE BOARD OF DIRECTORS FOR TRANSCO FOR A TERM OF THREE (3) YEARS
