## TERMS AND CONDITIONS

**ELIGIBILITY:** The ENERGY STAR Heat Pump Water Heater Rebate Incentive Program is available to all TTD residential electric service customers. Eligible measure must be installed in the service territory of the participating electric utility and in the premises indicated on this rebate application between January 1, 2020 and December 31, 2022. All rebate requests must be postmarked no later than January 31, 2023. Total incentive cannot be more than 50% of the total cost of the eligible ENERGY STAR Heat Pump Water Heater. Limit: One rebate per residential electric account in the MEUs service territories.

**Application Offer:** This Initiative covers products purchased on or after January 1, 2020, Details of this Initiative, including Rebate levels, are subject to change or cancellation without prior notice. This application form with required documentation must be received by January 31, 2023. Completed and signed applications must be submitted within 30 days of the equipment installation to be eligible for Rebates.

**Proof of Purchase:** An invoice itemizing the purchased equipment must accompany each Rebate application form. The invoice copy must indicate the equipment type, size, make and model, serial number of the system and date of purchase.

**Application Form:** This application must be filled out completely, truthfully and accurately. An authorized representative of the customer must sign, date, and submit the application along with the invoice, and manufacturer's equipment performance sheet stating the ARI certified efficiency rating and nominal capacity.

**Payment:** Please allow six to eight weeks for payment. Payment process may take longer if information is missing on application

**Approval and Verification:** Pre-approval from TTD will be required if the Rebate total is greater than \$1,000. TTD reserves the right to verify sales transactions and to have reasonable access to your facility, to inspect the equipment installed under this Initiative, prior to issuing Rebates, or at a later time.

**Endorsement:** TTD does not endorse any particular manufacturer, product or system design in promoting this Initiative.

**Tax Liability:** TTD will not be responsible for any tax liability that may be imposed on the customer as a result of the payment of Rebates.
